- The Haryana State AIDS Control Society (HSACS) is responsible for implementing the National AIDS Control Programme (NACP) Phase III in the State. The Government of India has received a Credit (Credit-4299-IN) from the funds pooled by the International Development Association and DFID in various currencies towards the cost of Third National HIV/AIDS Control Project and from Global Fund Round IInd and 6th and also providing funds from its Domestic Budget. It is intended that part of the proceeds of this credit will be applied to eligible payments under the contracts for which this invitation for Bids is issued. The National AIDS Control Organisation (NACO) is supporting the state programme. One of the principal objectives of the NACP-III is strengthening the infrastructure, operating systems and human resources in prevention, care, support and treatment programmes at the district, state and national levels. NACO releases funds to the SACS for the implementation of the National AIDS Control Programme. HSACS in turn funds peripherals organizations like NGOs and hospitals under the Government Sector. Hence it is essential to assess as to how the HSACS has discharged its
- fiduciary responsibilities.

  2. Expressions of interest are invited from CAG empanelled Chartered Accountant firms to conduct the internal audit of the peripherals units/NGOs of HSACS alongwith a selected one-fourth of the peripheral units on a quarterly basis in a financial year. The peripheral units could be rotated every quarter to ensure that all the peripheral units are covered in a financial year.

## ELIGIBILITY & ASSESSMENT CRITERIA: The firm must have a substantial presence in the State that they are

applying for in terms of branches and business. The Eol and capability would be assessed against evidence of skills and experience in providing accountancy and audit services in the State.
