### **REQUEST FOR PROPOSAL (RFP)**

Department of AYUSH seeks to invite Proposal from <u>C&AG empanelled Chartered</u> Accountant firms those are eligible for PSU audits for the year 2012-13/2013-14.

The details about the background of the auditee, scope of work, terms of reference and the eligibility criteria for selection of the Charetered Accountants Firms are given in the following paragraphs.

### Terms of Reference (ToR)

Department of AYUSH, AYUSH Bhawan, B-Block, GPO Complex, INA, New Delhi is implementing Four (4) Centrally Sponsored Schemes, in which funds were released to State Governments, through their Health Societies for implementation of the programme.

The following four schemes are as under:

### **Centrally Sponsored Schemes:**

- i. Development of Institutions.
- ii. Development of AYUSH Hospital and Dispensaries and mainstreaming of AYUSH under NRHM.
- iii. Quality Control of AYUSH Drugs.
- iv. National Mission on Medicinal Plants.

#### Objective of the Chartered Accountant Firm Services/Scope of Work

The objective of the appointment of the firm to ensure to separate the pending Utilization Certificates (UCs) of each scheme year-wise of the above mentioned schemes. In all there are approximate 3700 number of pending Utilization Certificates (UCs) amounting to Rs.1170.00 crores and approximate 3500 files of all these schemes.

The firm has to reconcile the Utilization Certificates (UCs) with Principal Accounts Office (P&AO), M/o H&FW, Nirman Bhawan, New Delhi record year-wise and scheme-wise in co-ordination with officials of implementing agencies. The information regarding pendency of UCs is available with PAO Office.

The firm has to do all the work at Head-Quarters of Department of AYUSH, AYUSH Bhawan, B-Block, GPO Complex, INA, New Delhi – 110023/Nirman Bhawan, New Delhi. The firm also to assist implementing agencies & coordinate to clear pendency of UCs.

**Standard:** - The firm is required to prepare, update the records and reconcile with PAO as per GFR provisions, and assist State Health Societies in settling clear pending UCs.

<u>Eligibility of CA Firms</u>: Chartered Accountants Firms those are empaneled with C&AG for the year 2012-13 and eligible for doing PSU audits. In this regards firm have to submit the details about the firm as per **Annexure – II.** 

<u>Audit Fees</u>: The firms those are interested to be appointed will have to quote consolidated fees including Service Tax and all other Charges etc.

<u>Time Schedule for completion of work:</u> Three months from the date of award of contract.

### **Guidelines for Submitting the Proposals:**

Agencies are required to submit the proposal as per the guidelines and formats detailed out in the following paras:

- i. Single Proposal: A firm should submit only one proposal. If a firm submits more than one proposal, it will be disqualified.
- ii. The firm should fill complete details in the format at Annexure II and Financial proposal at Annexure III alongwith Letter of Transmittal at Annexure I and should enclose EMD of Rs. 10.000/-.

- iii. Financial proposals submitted by the firm should be valid for 6 months from the date of submission of the proposal by the firm.
- iv. Each page, Form, Annexure and Appendices of the Proposal must be signed by the Authorized signatory of the firm.
- v. All blank spaces in the financial proposal must be filled in completely where indicated, either typed or written in ink.
- vi. The Department of AYUSH reserves the right to accept or reject any application without giving any explanation.

#### **Proposal will consist:**

- i. Letter of Transmittal (Annexure I)
- ii. Details of the Firm along with Details of Partners (Annexure II)
- iii. Financial Bid (Annexure III)
- iv. DD / Bankers cheque of Rs. 10,000/- as EMD. EMD will be returned to all unsuccessful firms after award of work.

### **Selection Process of the Firm:**

The detailed scheduled in regards to the tendering process shall be as under-

- (a) <u>Date for Publication of RFP</u>: The RFP should be placed on the Departmental website on the date of advertisement.
- (b) <u>Date of pre-bid conference</u>: The pre-bid meeting with prospective bidders will preferably be held on 7<sup>th</sup> day of Advertisement. This will also be informed on the web of the Department of AYUSH www.indianmedicine.nic.in.
- (c) <u>Last date and time for submission of Proposal</u>: by 3.00 P.M. on the 15<sup>th</sup> Day from the date of Publication of Advertisement excluding day of Advertisement.
- (d) <u>Date and time of opening of Tender</u>: Immediate After closing time of submission of proposal. The firms may be present at the time of opening of bids, if they wish.

The selection will be done by selecting the firm having lowest quotation in Financial Proposal (L-1).

<u>Payment Schedule</u>: The payment shall be made on the monthly basis i.e. first installment after completing one month on prorata basis of work completed.

Earnest Money Deposit (EMD): As a security deposit the firm has to deposit Earnest Money Deposit (EMD) amounting to Rs. 10,000/- (Rupees Ten Thousand Only) in the form of Demand Draft / Bankers cheque drawn in favour of 'PAY & ACCOUNT OFFICER(Sectt.), Ministry of Health & Family Welfare and payable at New Delhi. Which shall be kept as security deposit until the work is completed. The Department shall forfeit the EMD in case work is not completed within the stipulated period. The EMD of unsuccessful bidders shall be returned.
