- > ₹1.45 lakh crore gross GST revenue collected for November 2022; 11% increase YoY
- > Chennai GST Appeals-II Commissionerate launched a WhatsApp communication facility for taxpayers' facilitation
- GST Department began charging late fees to GSTR-1 defaulters
- > GST authorities lacks jurisdiction to determine correctness of transitional credit from erstwhile tax regime: Hon'ble Jharkhand High Court
- ➤ GST tribunal will be set up in Haryana, expected to start by March 2023 for the convenience of taxpayers and lawyers: CM Manohar Lal Khattar
